Terms and Conditions:

- International students are not subject to the domestic ASQA \$1,500 prepaid fee cap. Tuition Fees may change; however, once a Written Agreement and Letter of Offer are signed, the agreed tuition fees remain fixed for the duration of the course.
- Payment plans per term are available once initial payments are received. Students must follow the instalment schedule. Missed or late payments will trigger STC's overdue process, including 7/14/30/60/90-day notices, possible suspension of training, and referral to debt collection after 120 days. A \$50 late payment fee applies.
- The Application Fee is non-refundable. Tuition Fees are refundable only in accordance with STC's Financial Management Policy, the ESOS Act, and the Written Agreement. Refund applications must be submitted in writing.
- Any changes to the CoE end date or transferring to another RTO will incur a \$200 administrative fee.
- The SIT30821 course duration includes 40 weeks of tuition each academic year (4 terms × 10 weeks), orientation, breaks, holidays, and end-of-course completion activities. CoEs are issued for the full CRICOS duration i.e. 52 weeks.
- The course durations for SIT40521 and SIT50422 each include 20 weeks of scheduled tuition within their 26-week CRICOS durations. This includes orientation, academic breaks, holidays, and end-of-course completion activities. CoEs are issued for the full CRICOS duration for both courses.
- Students enrolling in packaged courses will receive Credit Transfer where units are common across courses. Tuition fees are adjusted so students only pay for the units they enrol in for the new course. Any change to the duration will be updated on the CoE and confirmed in writing.
